**ORDER:**

In the Government order first read above, orders were issued sanctioning of Ration Allowance @ Rs.360/- p.m. to the staff of “Grey Hounds” Unit of Police Department for the categories of employees specified in the Annexure to the G.O. In the Government order forth read above, orders were issued to continue the payment of Ration Allowance at the same rate of Rs.360/- p.m. even in the Revised Pay Scales, 2005.

2. In the Government order 2<sup>nd</sup> read above, orders were issued extending the Ration Allowance (as sanctioned to Grey Hounds staff) for extending the Ration Allowance @ Rs.360/- p.m. to the personnel of “Special Intelligence Branch” of the Police Department. In the G.O. fifth read above, orders were issued to continue the payment of this allowance at the same rates in Revised Pay Scales, 2005.

3. Based on the recommendation of Pay Revision Commission, 2005 orders were issued in the Government Order third read above, enhancing the rates of Ration Allowance payable to certain categories of Medical Department.

4. In the Government Order sixth read above, based on the recommendations of Ninth Pay Revision Commission orders were issued for implementing the Revised Pay Scales, 2010 to the State Government employees.

5. The Ninth Pay Revision Commission, among others, recommended for enhancement of the existing rates of Ration Allowance to the categories of employees of Medical Departments. In the case of staff of Grey Hounds and Special Intelligence Branch personnel of Police Department, the Pay Revision Commission recommended to increase the existing rate of Rs.360/- per month to Rs.450/- per month.

6. Government accepted the recommendations of the Ninth Pay Revision Commission, and hereby orders that the Ration Allowance be revised as shown in the fourth column of the Annexure to this Order to the categories of employees indicated therein.

7. These orders shall come into force with effect from **01.04.2010**.

8. Necessary amendments to the Andhra Pradesh Manual of Special Pays and Allowances wherever necessary will be issued in due course.
