2. G.O. Ms. No.52, Finance (PC.I) Department, dated: 25.02.2010.

ORDER:

Based on the recommendations of Pay Revision Commission, 2005 orders were issued in the Government Order first read above, revised the rates of E.S.I. Allowance to the categories shown in Annexure to that order.

2. Based on the recommendations of Ninth Pay Revision Commission, orders were issued in the Government Order second read above, implementing the Revised Pay Scales, 2010 to the State Government Employees.

3. The Ninth Pay Revision Commission, while observing that this allowance was allowed to the staff in the Insurance Medical Services Department, in the beginning, as an incentive to join in this department from the Medical and Health Department as the staff were originally recruited for Medical and Health Department. The Commission felt that there is no need to continue to pay this allowance who are recruited by the Department exclusively to work in this Department or got absorbed and suggested to Government to review the necessity to continue this E.S.I. Allowance. Pending review and decision by Government, Ninth Pay Revision Commission, recommended to continue to pay this allowance at the existing rates only.

4. Government have decided to accept the recommendations of the Ninth Pay Revision Commission, and hereby order that the E.S.I. Allowances be continued at the existing rates only as shown in column-3 of the Annexure to this Order to the categories indicated therein, pending review and decision by Government in the matter.

5. These orders shall come into force with effect from 01.04.2010.

6. Necessary amendments to the Andhra Pradesh Manual of Special Pays and Allowances wherever necessary will be issued in due course.

7. The Director, Insurance Medical Services Department is requested to review the necessity of the continuance of this allowance and send suitable proposals through

Labour, Employment and Training Department duly furnishing the information whether the staff now eligible for this allowance are drafted from Medical and Health Department and are still continuing on deputation basis or whether they were absorbed in the Department or whether they were recruited by the Insurance Medical Services Department.
